HEALTH ISSUES

Health Issues

Health and the availability of quality care is a primary concern in any community. The assessment looked at the availability of health care locally.

In telephone and face-to-face surveys, more than 80% of respondents said they have a regular source of health care, and 73% see a private doctor for their health care. Seventy-two percent of telephone respondents had seen their doctor in the past year, while 64% of face-to-face respondents had visited a doctor in the last year.

The majority of residents reported satisfaction with the medical care they receive: 59% of telephone respondents said they were "very satisfied" with their health care, while another 33% said they were "somewhat satisfied" with their care.

Although the majority of county residents do have health care, they are concerned about its availability nonetheless. In telephone surveying, 37% of respondents said they were "very concerned" about the access to care, with cost cited as the largest concern. Fifty-three percent of face-to-face survey respondents expressed concern over the access to care; of this group 65% were Latino, 60% had incomes less than \$15,000 and 54% were over 55 years of age.

Likewise, the majority of residents surveyed (85% of telephone respondents; 80% of face-to-face respondents) said they had health insurance. Their insurance often covers most medical needs, such as hospitalization, medical care, prescriptions and preventative care.

Of the 20% of face-to-face survey respondents who said they didn't have insurance, cost was the largest factor (58%), followed by an employer not offering the coverage.

When asked if either they or a household member had needed care in the past year but could not receive it, 10% of telephone survey respondents said yes; and 16% of face-to-face respondents said yes. Of this latter group, 23% were Latino, and 24% had incomes under \$15,000.

A regular source of dental care is indicated by a majority of residents as well, though there are too many residents who are lacking care. Fifty-four percent of face-to-face survey residents with

incomes under \$15,000, 53% of Latinos and 23% of senior citizens don't receive regular dental care.

While health and dental care is imperative, prenatal care is just as important for the health of mothers and their future children. The federal government has set high standards for prenatal care by the year 2000. In San Luis Obispo County, 80% of births between 1995-1997 had "adequate/adequate-plus" prenatal care. That is higher than the state average of 67% for the same time period.

The assessment looked at other health concerns, including death rates and incidence of disease. The three-year average, (1995-1997) leading cause of death in San Luis Obispo County were Malignant Neoplasms at 113.9 per 100,000 people. Heart Disease ranked second at 88.3 per 100,000 people. In 1997, the latest reporting period, there were 385 cases of AIDS in the county.

Another health concern is the use of drugs and alcohol. Surveying methods presented a measurement of local drug and alcohol use.

The telephone survey showed that 51% of county adults don't drink on a regular basis; 19% drink one-two drinks a week; and 18% have six or more drinks per week. Interestingly, there are more retail stores selling alcohol in the county than the state average; accounting for almost 13% of all taxable sales. Only 17% of telephone survey respondents, who were 18 or older, said they smoke.

An important Indicator of health in a community is that community's own perception of their health. When asked about their state of health, the majority of county residents reported positively: Twenty-one percent said they are in excellent health; 47% said their health is very good; and 27% said their health is good.

Residents also feel healthy emotionally. Twenty-six percent said their mental health is excellent; 47% said it is very good; and 21% said it is good.

Almost 50% of telephone respondents reported that they exercise five or more days a week, while 25% said they exercise at least three-four days a week. Twenty-eight percent of residents indicated they

were very concerned about weight management for themselves and their family.

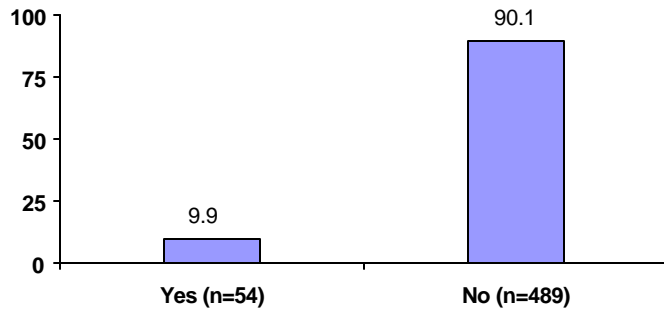
How satisfied are you with your medical care

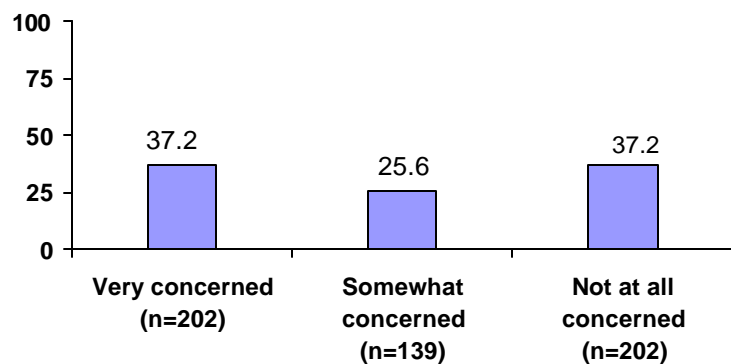

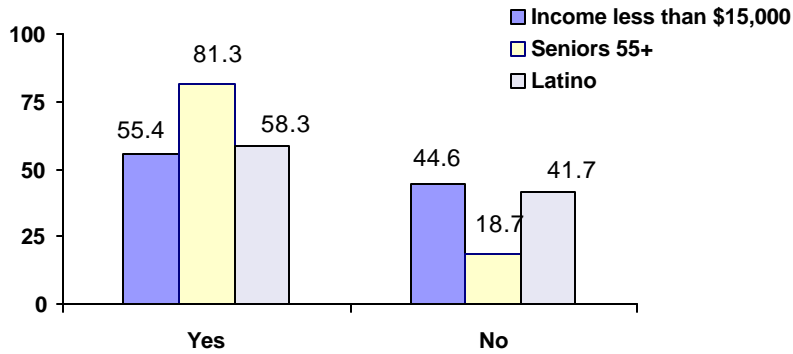
