APPENDIX 4

ADDITIONAL SOURCES OF DATA FOR SAN LUIS OBISPO COUNTY _____

This appendix briefly describes major sources of data about San Luis Obispo County.

California Healthy Kids Survey (CHKS) is a comprehensive self-reported youth survey of students in grades 5, 7, 9, and 11 in the public and private schools in California. The first survey was available in 1998, and was sponsored by the California Department of Education. The CHKS is an important component of California's school accountability system, and is an important tool in developing the district LEAP (Local Education Agency Plan). CHKS is widely regarded as the best available source of data on health-related risk behaviors and asset-based resilience of California youth. CHKS asks questions concerning:

- exposure to prevention and intervention activities
- resilience strengths and protective factors
- use of alcohol, tobacco, and other drugs
- violence, school safety, gang involvement, and delinquency
- nutrition and physical activity

Supplementary modules can be administered at the discretion of the school district and provide more detailed information regarding the subjects listed above.

School districts are required to administer the CHKS every other year to meet the program requirements of the SDFSCA (Safe and Drug-Free School and Communities Act), as specified in No Child Left Behind and the state

TUPE (Tobacco Use Prevention Education Program). The County Office of Education coordinates the CHKS for school districts in San Luis Obispo County. Countywide data from the 1999 and 2001 surveys has been published, and the third administration of the survey is scheduled for October 2003. The **California Health Interview Survey** (CHIS) is a statewide telephone survey about public health topics and access to health care that is conducted every two years. CHIS provides information on where and how people get health care as well as the number of adults and children without health insurance. CHIS also collects information on important health conditions such as cancer, diabetes, and asthma. CHIS is the largest state health survey, and is considered the best source of health related data for the state and its counties.

Statewide, the 2001 inaugural survey included interviews with over 55,000 adults, 5,000 teenagers, and 12,000 parents of children under age 12. The 2001 survey included interviews with 800 adults in San Luis Obispo County. CHIS provides county level results, but no data for any subgroups within the county. County results can be accessed at: <http://www.chis.ucla.edu/main/default.asp>. The results of the 2003 survey are expected to be released some time in 2004.

The ACTION for Healthy Communities 2003 Comprehensive Report includes selected results from the 2001 CHIS survey. In addition, ACTION is changing some of its questions to match those used in CHIS so that future data will be comparable, and available for subgroups within the county.

The **San Luis Obispo County Latino Needs Survey 2002** reports on the health, education, social service, housing, childcare, and transportation needs of monolingual Latinos in San Luis Obispo County. The data were collected from approximately 164 Latinos who participated in platicas, or community meetings, held in early 2002. The six platicas were held in Paso Robles, Shandon, Cambria, Estero Bay, San Luis Obispo, and Grover Beach. Participants came to the platicas as a result of public invitations distributed in schools and through community organizations. Although the survey results may not perfectly represent the opinions of all monolingual Latinos in the County, they are still useful for policy makers.

The HOTLINE and EOC are conducting additional platicas in early 2003. Many of the questions asked of 2003 participants are identical to those asked in the ACTION for Healthy Communities surveys. This will provide comparability of results, and an additional way to gauge the needs of the monolingual Latino population in San Luis Obispo County.

The **San Luis Obispo County Economic Outlook** is an annual publication of the UCSB Economic Forecast Project. The publication is sponsored primarily by local businesses, and is guided by a San Luis Obispo County Board of Directors. The publication includes historic data and forecasts for: total economic activity, employment, population, and community data, with special emphasis on important local industries such as real estate, tourism, retail and agriculture. The Economic Outlook is the definitive chronicle of economic activity in the County. The Economic Forecast Project also provides reports and presentations to cities that desire more local information.

Under contract to ACTION for Healthy Communities, the Economic Forecast Project conducted the 2003 countywide telephone survey and prepared this Comprehensive Report and the companion Indicator Report.

The **Community Health Status Report for San Luis Obispo County** provides an overview of some of the key community health trends in the county. It is published irregularly, with the latest edition produced in January 2003. The primary sections of the report are (I) community overview, (II) maternal, child and adolescent health, (III) communicable and infectious disease, and (IV) leading causes of illnesses, injury or death. As much as possible, the county's local health status is compared with that of the State, and when available, to the national Healthy People 2010 objectives. In addition to health or medically related indicators, some socioeconomic factors that may influence the health status of populations have been included.

The **2000 Census of Population and Housing** provides detailed data about the residents of San Luis Obispo County, reported at various geographic levels, in some cases down to the Census Block, which often corresponds to a single city block. The Census includes a wealth of data on demographic, socio-economic, and educational characteristics, as well as housing, transportation, languages spoken, migration, and other topics.

The most comprehensive Bureau of the Census website is: www.census.gov. On that page is a particularly useful link to a search engine called the American Fact Finder: <http://factfinder.census.gov/servlet/BasicFactsServlet>. This site allows the user to select either categories of data by geography, or to go directly into one of the 4 Summary Files the Census Bureau uses to organize data. Another Bureau of the Census site that is easier to navigate, but limited to countywide data, is: <http://quickfacts.census.gov/qfd/>. Several commercial websites provide Census-based data in easier to use formats but with fees.

Locally, the San Luis Obispo Council of Governments is the designated Census Data Affiliate for the County. SLOCOG's website - www.slocog.org - has a link to Census data: <http://www.slocog.org/maps/census.html> - and shows basic 2000 Census data for the County, for each incorporated city, and for nine unincorporated communities in the County.
